

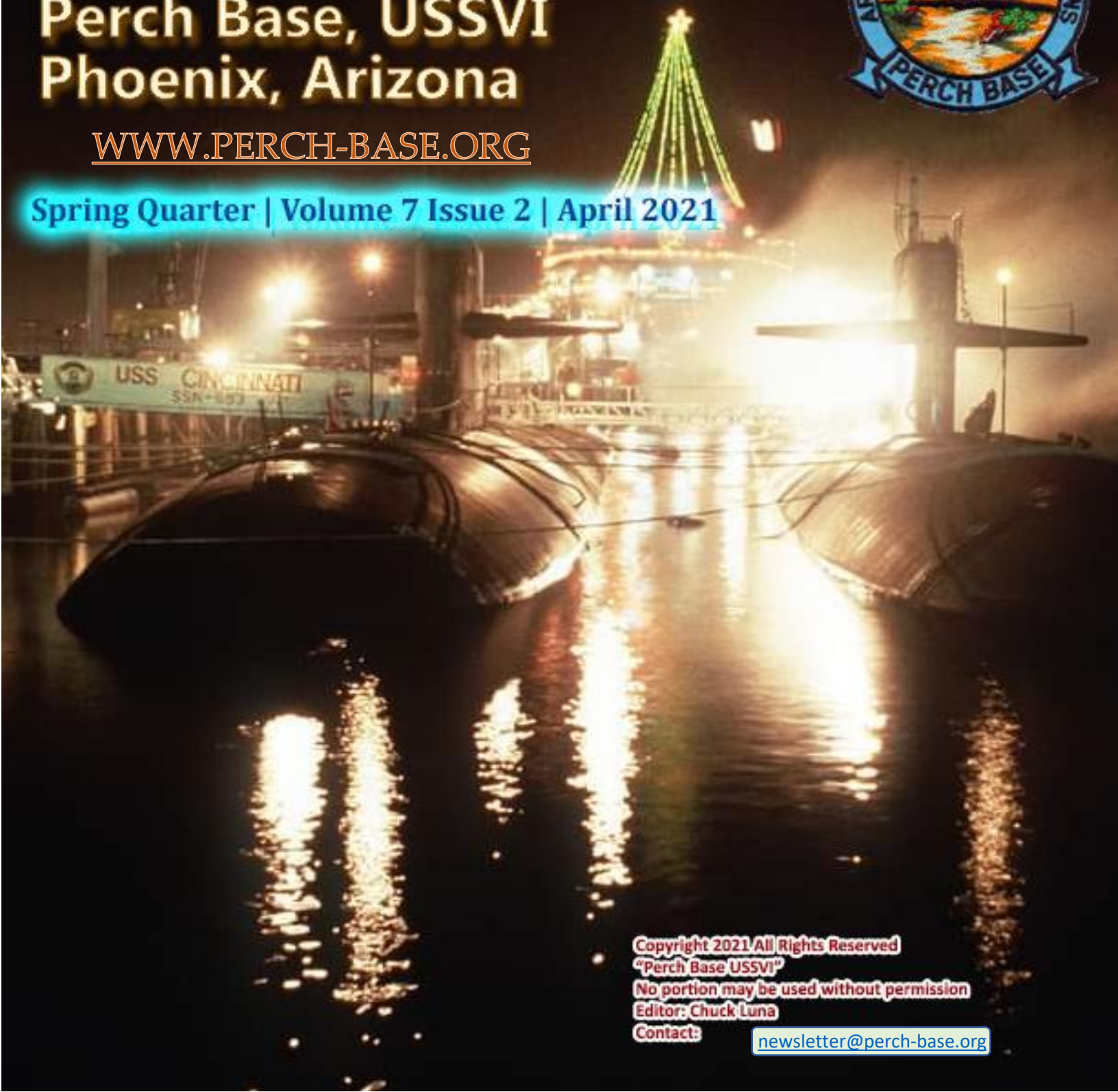

Our organization's purpose is . . .

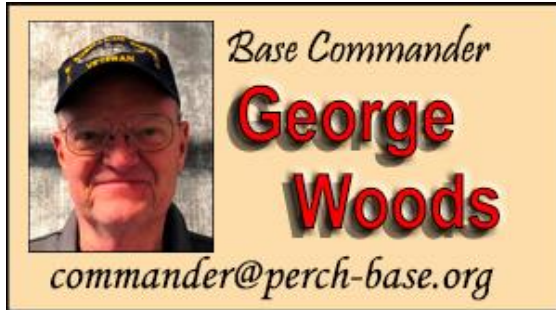

With the recent passing on Eternal Patrol of our Perch Base Life Member and Holland Club member Lou Reynolds, I am curious of any other members that may have participated in the Veterans Heritage Project (formerly Arizona Heritage Project.)

The mission of the Veterans Heritage Project is to Connect Students with

Veterans™ in order to honor veterans, preserve America's heritage, and develop future leaders. Helping to bridge the gap between civilian and military life, they strive to develop students' character and civic responsibility, while recognizing our veterans' legacy of service. High School students, often with an interest in journalism, are paired up with a veteran and they write an article, similar to a short biography of the veteran's past. It is published in a book titled "Since You Asked." There have been 16 annual volumes issued, many of the annual volumes have up to 4 editions. As of the publishing of this Midwatch, there have been 2,322 veterans interviewed.

I have obtained and read the articles in "Since You Asked" for our Perch Base members Captain Dick Noreika, Jim Denzien and Lou Reynolds. I would like to know if any other members have been interviewed. Let me know if I am missing anyone.

During the previous three months, there were 2,493 page views on the Perch Base website during 1,232 sessions by 915 users based on Google Analytics. These numbers seem typical. Approximately 76% of the sessions originated in the US, 9% from China, 3% from the United Kingdom, and the remainder were widely scattered around the world. Approximately 24% of the U.S. based sessions were from locations in Arizona, which is assumed to come from our membership. 30% of the traffic was to the home page, 18% to the Glossary, 14% to the submarine videos, 4% to the Sailing Orders page, 3% to the Eternal Patrol page, 3% to the Lou Reynolds Eternal Patrol Notice, and 2% to the ASSM Construction page.

During February, the Facebook PAGE had 46 Page Views (number of times a PAGE's profile has been viewed,) 10 Page Likes (the number of new people who liked our page,) 27 Post Reach (number of people who saw any post at least once) and 6 Post Engagement (number of times people engaged with posts thru reactions, comments, shares and clicks).

They're Back: US Subs To Carry Harpoon Ship-Killer Missiles

The effort falls in line with Pentagon efforts to deploy more punch at longer ranges, a clear recognition of the growing ability of China and Russia to keep American and forces at a stand-off distance

WASHINGTON: After a 25-year absence, the Navy will start packing Harpoon ship-killer missiles on its attack submarines as the fleet looks for new ways to counter the growing Chinese navy.

The effort falls in line with a range of programs the Pentagon is pursuing to develop ways to deploy more offensive punch at longer ranges, a clear recognition of the growing ability of China and Russia to keep American and allied forces at a distance in any potential confrontation.

The Harpoon work was capped off late last month when the Navy awarded Boeing a \$10 million contract to arm Los Angeles-class attack subs with the new Harpoons as soon as this year. The contract follows the successful test firing of a Harpoon from the USS Olympia submarine during the RIMPAC 2018 exercise off the coast of Hawaii, marking the first time the missile had been fired from an American sub since 1997.

The Pentagon has been working on getting its ship-killing prowess back since the Obama administration, when then-Defense Secretary Ash Carter launched the Third Offset Strategy aimed at developing new technologies, and repurposing old ones, to make the force more lethal, at moderate cost — and to do it quickly.

The increased missile range also fits with the emerging Navy strategy which accepts the risk posed by precision weapons and stand-off capability developed by China, in particular. A “tri-service” strategy released by the Navy, Marines and Coast Guard in December pointed out the plan is to continue to develop “ready, forward-deployed naval forces [which] will accept calculated tactical risks and adopt a more assertive posture in our day-to-day operations.”

The work began to pay off in the fielding of the over-the-horizon Naval Strike Missile, made by a team made up of Raytheon and Norway-based Kongsberg. The weapon, with a range of about 100 miles (roughly comparable to the Harpoon), has been deployed aboard the Littoral Combat Ship USS Gabrielle Giffords, and will become a mainstay aboard the Constellation-class frigates which begin construction this year.

The entire fleet of more than 30 Littoral Combat Ships will eventually be equipped with the NSM, Navy CNO Adm. Mike Gilday told Breaking Defense recently.

“In today’s competitive space with China, in particular, you need lethal systems like the Naval Strike Missile on every single and every single LCS that we have. And so in order to and so, I do want those ships deployed in numbers,” Gilday said.

The Navy and Marine Corps are also looking for ways to get the NSM fitted aboard its amphibious ships, a move that advances the emerging plan to find ways to add more punch to the US fleet as China and Russia push their own long-range weapons out to sea.

“We have these magnificent 600-foot-long, highly survivable, highly LPD 17s,” Marine Maj. Gen. Tracy King, the Navy’s director of expeditionary warfare, told reporters last month. “The LPDs need the ability to reach out and defend themselves and sink another ship. It’s not from the aspect of using them as a strike platform; it will drastically increase their survivability if the enemy has to honor that threat.”

Putting those missiles aboard large, amphibious ships also wielding F-35Bs is in line with the Corps’ efforts to find a way to fire long-range anti-ship missiles from shore-based ground vehicles to support the fleet from dispersed locations. Last year, Raytheon was awarded \$48 million to integrate the NSM into the Marine Corps’ force structure, following a year-long study the Corps conducted, where it also considered Lockheed Martin’s new Long-Range Anti-Ship Missile and the Harpoon.

In December, the Navy also fired a new version of the Cold War stalwart Tomahawk missile from the destroyer USS Chafee, giving the surface fleet an expanded ability to target ships and land targets at greater range. The Black V Tomahawk is expected to reach ranges in excess of 1,000 miles with a new warhead that will carry a bigger punch than older versions.

Task Force Calls for Permanent National Guard Force to Protect DC

A task force charged with making recommendations to boost congressional security after a deadly Jan. 6 pro-Trump mob assault on Capitol Hill has proposed establishing a permanent military presence ready to go at a moment's notice in Washington, D.C.

The security review, led by retired Army Lt. Gen. Russel Honoré, who ran military relief efforts for Hurricane Katrina, recommended establishing a permanent National Guard quick reaction force, or QRF, for all of D.C.

A QRF is a standard military security element meant to provide swift reinforcements.

"This could be done by mobilizing military police from Guard elements across the U.S. on rotations of three to six months," the task force's report states. "Another option would be to create a QRF that permanently resides within the D.C. Guard by reestablishing a military police battalion and staffing it with active Guard reserve troops who live in or near the city year-round, perpetually on active duty."

The proposal notes that military forces should be a supplement to a law enforcement QRF. Establishing a permanent National Guard presence could be a costly measure for the military, especially if states must continue to rotate troops and equipment in and out. Basic Allowance for Housing for an Army specialist, the most common rank in the force, is \$2,520 per month in the D.C. area without dependents. That is on top of standard pay.

National Guard troops also must maintain civilian jobs, which could be a challenge. Guard troops would have to stay activated under federal orders for legal protections from employer retaliation.

Troops, if serving under Title 32 federal orders under a presidential emergency declaration, would also accrue benefits under the Department of Veterans Affairs, such as qualifying for the Post-9/11 GI Bill. The VA spends an average of \$17,400 per GI Bill beneficiary, according to the Congressional Budget Office.

Under the current law, the president would have to declare a constant state of emergency for Guard troops to accrue federal benefits.

Immediately after the mob stormed the Capitol, 26,000 Guard troops from around the country were mobilized. About 5,200 remain on the Capitol security

mission. Five people died during the siege, including Capitol Hill police officer Brian Sicknick.

The recommendations come a week after the commander of the D.C. National Guard testified that unusual restrictions by the Pentagon during the Trump administration hindered his ability to quickly deploy troops as the mob assaulted Capitol Hill.

Maj. Gen. William Walker told members of the Senate Committee on Homeland Security & Governmental Affairs that he could have begun sending Guard members to support D.C. law enforcement, under siege by a rioting crowd, hours earlier but was hampered by a strict Pentagon approval process, indecisive leadership and sluggish communication.

To combat the slow military response, the task force report makes an unprecedented request to give the commander for the D.C. Guard the authority to deploy troops without the president's permission under extreme circumstances -- something that could raise significant questions on the integrity of civilian control of the military.

"We recommend ... the commanding general of the D.C. National Guard shall retain 'emergency authority' ... in extraordinary emergency circumstances where prior authorization by the president is impossible and duly constituted local authorities are unable to control the situation, to engage temporarily in activities that are necessary to quell large-scale, unexpected 'civil disturbances' when necessary 'to prevent significant loss of life or wanton destruction of property and are necessary to restore governmental function and proper order,'" the report states.

Navy Grappling with Bedbug Infestation of Nuclear Submarine USS Connecticut

SEATTLE — Clothes got laundered, mattresses replaced and pesticides sprayed as the [Navy](#) waged war against a stubborn infestation of bedbugs that found their way onto a nuclear-powered submarine at its home port in the Bremerton area.

Navy entomologists now certify that "all feasible measures have been taken" to control the infestation and have recommended "repopulation of berthing," according to a statement from Cmdr. Cindy Fields, a public affairs officer for the Naval Submarine Forces Pacific.

This campaign aboard the USS Connecticut has included laying down diatomaceous dust to draw insects out of hiding and into contact with this "deadly" countermeasure, according to the statement.

But the Navy's efforts have not quelled concerns from crew members, some of whom have been sleeping on cots in a pier-side shelter erected as temporary quarters to avoid getting bitten in the submarine "racks" where people sleep.

"They are really frustrated and feel like they have been let down by the Navy," said Jeffery Rachall, who previously served aboard the submarine and — since leaving military service in 2018 — has remained in close contact with other crew. "They are complaining about a lack of sleep. They itch, and the bugs are crawling all over."

Bedbugs are oval-shaped insects, about one-quarter inch long when fully grown, that feed on blood from humans and some animals. They can be transported into hotels, homes and boats on people's clothing, luggage or other personal belongings. They often take up residence in beds, where they may leave small spots that mark their presence. Though bites swell and become itchy, it may take two days or more for them to show up.

It is unclear how the infestation started on the USS Connecticut, but it's possible it was during a port stop, according to Rachall.

The USS Connecticut is a nuclear-powered, fast-attack submarine launched in 1997 that was transferred to a Washington home port in 2011. It can be used to conduct reconnaissance and protect Navy fleets.

The infestation on the USS Connecticut was spotlighted in a recent article in the Navy Times. It included an interview with an unnamed petty officer who said that the bedbug infestation first became an issue during a deployment in the Arctic Ocean in March 2020, and that the fatigue from bedbugs' presence has become a safety issue.

"If someone's sleep-deprived because they're in the rack getting eaten alive by bedbugs, he could fall asleep (at the controls) and run us into an underwater mountain," the petty officer told the Navy Times.

The Navy Times also reported that some petty officers allege that the command is forcing sailors to return to sleeping in the racks this week during training, when the entire sub crew will be on board.

The Navy public affairs officer said that the first reports of bedbugs were not made until December of last year. Initial inspections that month did not detect

them. Then, around Feb. 19, the "physical presence of bed bugs" was established, a requirement for the treatment. Daily inspections have occurred since then, with the two Navy entomologists arriving March 4 "to direct hands on efforts," said the statement from Fields.

"The Navy takes the safety and health of Sailors very seriously," Fields wrote.

Austin approves request to extend National Guard deployment at US Capitol

WASHINGTON — An extension of the National Guard deployment at the U.S. Capitol has been approved through May 23.

Defense Secretary Lloyd Austin approved the request late Tuesday for nearly 2,300 Guard troops continue to provide security in Washington, D.C., at the request of the Capitol Police, amid worries about continued threats. Officials have been scrambling in recent days to determine if and how to fill the request for more than 2,000 Guard forces, as the original March 12 deadline for them to leave Washington looms.

The 2,300 figure is nearly a 50 percent reduction of the current support force, according to a Pentagon press release. DoD officials will work with U.S. Capitol Police to incrementally reduce the Guard footprint as conditions allows, Pentagon Press Secretary John Kirby said in the release.

The decision underscores concerns about the ongoing threat of violence at the Capitol, two months after rioters breached the building in violence that left five people dead. Law enforcement have remained in a heightened security posture in response to intelligence suggesting possible threats to the Capitol by militia groups.

The request to extend the deployment met resistance last week, as some governors expressed reluctance or flatly refused to commit their troops to more time in the city. There now appears to be enough states willing to provide Guard troops for the mission, said the defense officials, who spoke on condition of anonymity to discuss internal deliberations.

Army leaders had also initially questioned whether the Capitol Police had exhausted all other options to fill the need, such as asking other federal law

enforcement agencies to provide security. But officials said military leaders thought it was important to find ways to work out the details.

It was unclear Tuesday if Guard troops currently in Washington would have to stay an extra day or two while the new forces arrive and get trained and settled in.

The threat was tied to the far-right conspiracy theory promoted by QAnon supporters that former President Donald Trump would rise again to power on March 4, the original presidential inauguration day. That day passed with no problems, but law enforcement has said threats to buildings and personnel remain.

The Guard's deployment to the Capitol has been troubled. Early on, Guard members were briefly forced to take rest breaks and meals in a nearby cold garage, sparking outrage within the Biden administration. Officials quickly found new spaces within congressional buildings for the on-duty breaks.

In addition, Guard members complained of bad food, including some who said they became sick. On Monday, Kirby said that about 50 Guard troops had been treated for gastrointestinal issues, out of the 26,000 that deployed to Washington. He said six sought outpatient medical treatment, while the rest were treated at aid stations set up for the Capitol Hill mission.

Kirby said that Gen. Daniel Hokanson, chief of the National Guard Bureau, has been visiting the troops several times a week and eating with them to ensure that they were getting good food.

Acting Capitol Police Chief Yogananda Pittman made the request to have the Guard members stay on, setting off a series of discussions with the Pentagon and National Guard leaders.

U.S. military officials have said the cost of deploying about 26,000 Guard troops to the U.S. Capitol from shortly after the Jan. 6 riot to this Friday, is close to \$500 million. No cost estimate for the next two months has been released. The costs include housing, transportation, salaries, benefits and other essentials.

Congressional Democrats propose bill to halt nuclear SLCM

Congressional Democrats have proposed legislation to stop work on the nuclear-armed sea-launched cruise missile program, a program which the Pentagon restarted in 2018. Rep. Joe Courtney (D-CT) and Sen. Chris Van Hollen (D-MD)

introduced a bill last week to stop research and development, production and deployment of the N-SLCM. The bill was first reported by Politico.

"The Trump-era program to arm our naval vessels with nuclear-tipped cruise missiles is not only reckless, it's costly and unnecessary," Van Hollen said in a press release. "This move would unduly burden our Navy -- taking away from its core conventional missions -- and would prevent vital resources from going where they're truly needed."

The Navy plans to wrap up an analysis of alternatives for a new nuclear-tipped, submarine-launched cruise missile this summer to support the launch of developing the program in fiscal year 2022. Vice Adm. Johnny Wolfe, head of Strategic Systems Programs, said during a January event that the Navy was reviewing potential alternatives for a follow-on to the nuclear-armed Tomahawk cruise missile.

"Based on the outcome of that AOA and based on what the AOA says would be the right course of action to take to have a sea-launched cruise missile, then we would start taking whatever the AOA said and then start to look at how would I design it, how would I started to integrate it," Wolfe said. The Trump administration called to reinstate the N-SLCM program in its 2018 Nuclear Posture Review after the Obama administration retired the nuclear-armed Tomahawk missiles. The NPR stated that the development of a new SLCM could convince Russia to re-enter compliance with the 1987 INF Treaty.

"Given the increasing need for flexible and low-yield options to strengthen deterrence and assurance, we will immediately begin efforts to restore this capability by initiating a capabilities study leading to an Analysis of Alternatives (AOA) for the rapid development of a modern SLCM," the NPR states. The Congressional Budget Office projected in 2019 that the N-SLCM would cost \$9 billion from 2019 to 2028. Courtney said in a press release that funding the SLCM would take away much-needed funding from plans to grow the Navy's fleet. He said Congress is committed to the Columbia-class submarine as the sea-based nuclear deterrent. Installing the SLCM on Virginia-class submarines would also hinder plans to construct three Virginia-class attack submarines per year, according to Courtney.

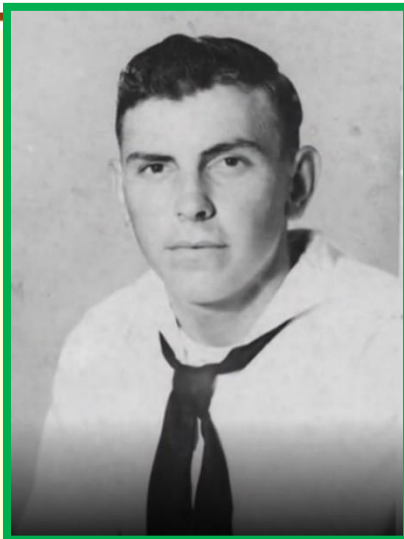
"The critical mission of attack submarines with ship-killer conventional Tomahawk missiles is in the highest demand in the Indo-Pacific and European theater," he said. "Loading them with nukes that require a whole host of new apparatuses, training, and restricted movements will hinder, not help, their ability to deter aggressive actions by our adversaries."

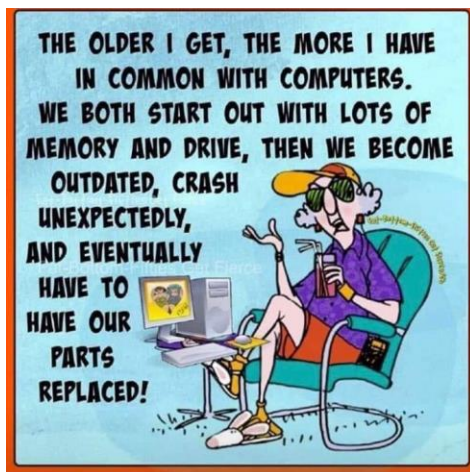
